To bring the Comprehensive Plan into compliance with Florida law, by amending **Capital Improvement Element** Policy 8.1.3.1-2 to return to, and maintain, the currently acceptable level of service standard "C" in the current duly adopted comprehensive plan for all roads in Yankeetown based on existing traffic data and analysis. Should the remedial amendment to the comprehensive plan be approved?

A policy that shall establish a stormwater utility fee to provide funding for stormwater drainage facilities and noting in the plan that the Town anticipates matching grants and if no grants can be obtained or the stormwater utility fee is not adopted or approved, stormwater projects will be funded from general fund reserve or long term loans. REMEDIAL AMENDMENTS TO THE TOWN OF YANKEETOWN COMPREHENSIVE PLAN, HOUSING ELEMENT

To bring the Comprehensive Plan into compliance with Florida law to update the **Housing Element** by changing the: long term planning horizon from 2040 to 2020; 5 year population projections for 2010, 2015, 2020; current number of housing units 423 to 450; needed additional 460 105 housing units by 2040 2020; the age of many structures from 59 to 60 years or older by 2020. Should the remedial amendments to the comprehensive plan be approved?
